

**OFFICIAL RULES - Beautyrest® Mattress Giveaway Sweepstakes**

**NO PURCHASE NECESSARY TO ENTER OR WIN. THE PURCHASE OF ANY GOOD OR SERVICE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**THESE OFFICIAL RULES ("RULES") ARE A LEGALLY BINDING AGREEMENT BY AND BETWEEN YOU AND SPONSOR AND GOVERN YOUR ENTRY IN THE SWEEPSTAKES.**

- 1. SPONSOR:** The sponsor of this sweepstakes ("Sweepstakes") is BEAUTYREST CANADA, a division of SSH Bedding Canada Co. 2550 Meadowvale Blvd. Unit #1 Mississauga, ON L5N 8C2 the maker of Beautyrest mattresses. ("Sponsor").

SWEEPSTAKES ENTRY PERIOD:** The Sweepstakes entry period begins on April 1, 2019 at 12:00 AM Eastern Standard Time and ends on June 11, 2019 at 11:59 PM Eastern Standard Time ("Promotion Period"). At the end of the Promotion Period, there will be three (3) random draws for three (3) Grand Prizes as set forth in these Rules, with one winner selected for each prize.
- 3. ELIGIBILITY:** The Sweepstakes is open to legal residents of Canada (excluding Quebec) who are age of majority or older at time of entry. Void where prohibited. Current or former employees of Sponsor or its suppliers, representatives, and agents, their immediate families, and/or members of their households, are not eligible to enter.
- 4. HOW TO ENTER:** Participants must complete the contest entry form at [www.beautyrest.ca](http://www.beautyrest.ca). Limit one (1) entry per household. Do not create multiple accounts in order to enter multiple times. If, in the opinion and sole and absolute discretion of Sponsor, an entry violates any law or infringes upon the rights of any third party, is inaccurate, illegible, incomplete or irregular in any way, disparages Sponsor, its products, or any third party, contains any type of inappropriate language, or otherwise does not comply with these Rules, Sponsor may disqualify the entry. The Sponsor reserves the right to, and at its sole discretion may, reject any entry for failure to comply with these entry requirements.

Each of these entrants will be deemed a potential winner pending verification of eligibility and compliance with these Rules; the winner has three (3) business days to respond with verification of eligibility.

6. **PRIZES, APPROXIMATE RETAIL VALUE, AND ODDS OF WINNING:**

Three (3) Grand Prizes consisting of one (1) Beautyrest® Mattress (queen size). The mattress type is dependent on the availability of product and will be determined upon draw. The approximate retail value of the Grand Prize ranges between \$400-\$3,499CAD.

One Grand Prize will be awarded during each Drawing Period, for a total of three (3) prizes.

Delivery of the mattresses will be at cost of the supplier, and at no charge to the winner.

The odds of winning a Grand Prize depend on the number of eligible entries received during each Drawing Period.

7. **GENERAL PRIZE CONDITIONS:** Limit one (1) prize per household during the entire Promotion Period. The right to receive a prize is non-assignable, non-transferable and no prize substitution, exchange or cash equivalent will not be allowed, except by Sponsor who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure. In order to win a Grand Prize each potential winner will be required to correctly answer a mathematical skill-testing question, without assistance or mechanical or electronic aid, and sign a Declaration and Release Form confirming compliance with the Contest Rules and acceptance of the Grand Prize as awarded.
